Gentlemen of the Senate,

The constitution and form of government having directed that the governor of this state shall be chosen on the second Monday of December in each and every year, and this being the day prescribed, we prop se, with the concurrence of your honourable hody, to proceed to elect the governor of the state at 12 o'clock to day. Samuel Sprigg and Charles Goldsborough are put in nomination by this house, and we have appointed Messrs. Marriott and W. Eccleston, to join such gentlemen as may be named by you, to count the ballots and report thereon.
