The bill to authorise the levy court of Cecil county to levy a sum of money for the purposes therein mentioned, was read the second time, passed, and sent to the senate.

On motion by Ler S. Stevens, the question was put, I hat Leave be given to bring in a bill, entitled An act to authorise the registers of the land offices to record certificates of surveys? Determined in the megative.

The resolution relative to the penitentiary was sent to the senate.

On motion by Mr. T. Kennedy, the following resolutions were read the first and second time.

Whereas the congress of the United States did at the last session, pass a bill, entitled, An act design nating the parts within which only foreign armed vessels shall be permitted to enter, which in its effect is particularly prejudicial to the interests of the state of Maryland; therefore, Resolved, That our sens tors and representatives in the congress of the United States be requested to use their best endeavours effect the repeal of the aforesaid act, either in whole or in part, and particularly so, that foreign armed vessels, belonging to any European power, may hereafter be admitted into any port or ports within the Chesapeake bay or its waters.

Resolved, That his excellency the governor be requested to transmit a copy of the preceding resolution to our senators and representatives, to be by them submitted to the consideration of both house of

congress.

And the question was put, That the house assent to the same? Determined in the negative.

The bill to confirm the appointment of collector of the tax for Charles county, and for other purpose, was read the second time, passed, and sent to the senate.

The clerk of the senate delivers the bill for the relief of Charlotte Warfield; the bill to authorise Man Young to bring a slave into the state; the bill for the benefit of Elizabeth Dickens; the bill to incorporate the Medical Society of Baltimore; the further supplement to the act to authorise a lottery or lotters in the city of Baltimore; the bill for the benefit of Joseph Jameson and Frederick Johnson; the bill for the benefit of Henry W. Fitzhugh; the bill to declare void certain deeds therein mentioned, and to confirm others; and the bill to; incorporate a Lutheran Church in Reister's-town, severally endorsed and pass." Ordered to be engrossed. The bill for the relief of Hector Perkins and James M. Cann; the bill for the relief of Anthony Yerkess; and the bill for the relief of the Library Company of Baltimore, w verally endorsed "will pass with the proposed amendments;" which amendments were read, assented to and the bills ordered to be engrossed. Also a bill, entitled, An act for the relief of Littleton Denni Teackle, of Somerset county, endorsed "will pass;" which was read. And the resolution relative to farm hing the government house endorsed "assented to."

The bill for the more effectual amendment of legal proceedings, was read the second time; and on me tion by Mr. B. Forrest, the question was put, That the following section be stricken out? "That is a actions now existing, or hereafter to be instituted in any of the courts of law of this state, the courts we spectively in which such actions are, or shall be depending, may in their discretion, and on motion either party, either before or after the jury shall be sworn, order any amendment to be made in the wife or any other proceeding, although such amendment may vary or change the form of the action; provi ded such court shall be satisfied that such amendment is necessary for bringing the merits of the case fairly to trial on the law and the facts; and the said court, in all cases where, in its judgment, the party against whom such amendment is moved for, has been or will be put to any costs by the amendment, in consequence of the mistake or defect which renders it necessary, greater than would have been income red is such mistake or delect had not existed, or been committed, shall have power to order such additional costs to be paid by the party applying for the amendment." Resolved in the affirmative.
