The committee appointed on the part of this house to visit and inspect the Penitentiary, ask leave to report: That in discharging the duty assigned to them they have the satisfaction to state, that they found the institution in a situation highly creditable to those entrusted with its immedia direction and management, upwords of three hundred criminals of different ages and sex, being industriously employed in various branches of manufactures and mechanics, adapted to their respective capacities; thus converting the establishment into an exclusive work shop, in which each convict is acquiring habits of industry, and a thorough knowledge of some useful trade, by which they may obtain an honest livelihood when their term of service shall have expired. The committee learn from the board of inspectors who politely accompanied them through the institution, that although at this time, the amount of profit derived from productive labor, is fully adequate to its expenses, yet they are much embarrassed in their operations, by a heavy debt incurred in the insipient stages of its establishment, from want of proper experience in directing their attention to the most advantageous branches of industry, and in purchasing articles of clothing, hedding, &c. all of which are now manufactured of a most durable and excellent quality within their own walls.

The committee cannot conclude without an expression of an opinion, that in no other manner could those violators of the peace of society, and of the laws of their country, be more suitably and economically provided for, with a view to their proper punishment and reformation, and as it regards

the interest and tranquility of the community
