The house proceeded to ballot for a speaker, the ballots being deposited in the ballot box, on examination thereof it appeared, that William H. Marriott, Esquire, was unanimously elected. John Brewer was appointed chief clerk, and Richard Bennett assistant clerk. Ordered, that they be qualified as such, by taking the several oaths required, by subscribing a declaration of their belief in the christian religion, and by taking an oath that they will honestly, faithfully and diligently discharge the duties of their offices, and that they will not reveal or disclose the seerets of the house.
