or sums of money whatever, than to the current amount by him payable into the common fund of the society? Determined in the negative. The question was then put, shall the said bill pass? Resolved in the affirmative, and the bill sent to the senate.

On motion by Mr. T. Kennedy, the following order was read and assented to:

Ordered, That the treasurers of the Western and Eastern Shores furnish to this house a statement of the amount of monies received into their respective treasuries under the act, entitled, An act laying duties on retailers of dry goods, and for other purposes, passed at December session, 1819, chapter 184—and under the supplementary act thereto, which requires importers and wholesale merchants to take out licenses, passed at December session, 1821, chapter 240, shewing particularly the amount received from each county. Also that they furnish a statement of the moniestreceived into the treasury under the act entitled, An act taxing or licensing certain dealers in lottery tickets and others, passed at December session, 1821, chapter 232.
