"Ind be it enacted, That if said commissioners, after having heard all the testimony which they are authorised to receive under this act, shall report to the next general assembly, whether any divisional line between Calvert and Anne-Arundel is now ascertained, and if any, where said line now runs?" Determined in the negative.

On motion by Mr. Estep, his name was stricken out, and Virgil Maxey was inserted. On motion by Mr. Estep, the words "for Prince George's county, Julius Forrest was stricken

On motion by Mr. Thomas, the words "Doct. William Howard of Baltimore county," was inserted in lieu thereof.

On motion by Mr. Estep, the preamble was reconsidered, and the words "and in particular, divers persons living near the borders of those counties have not contributed any thing towards the public expenses," were stricken out.

On motion by Mr. Estep, the word "will" was inserted between the words "not ascertained."

On motion by Mr. Dalrymple, the following was added to the bill:

shall take the following oath or affirmation: I, A.B, do solemnly swear or affirm, as the case may be, that I will well and truly perform the duties of commissioners as prescribed by this act, without favor, affection, partiality or prejudice, to the best of my skill and judgment, so help me God.

"And be it enacted, That if any vacancy or vacancies shall occur in said commission, by the resignation, death or refusal to act, or any other cause, of one or more of the said commissioners, the governor and council are hereby authorised and required to fill such vacancy or vacancies so accurring, by appointing a commissioner or commissioners, as the case may be.
