*Resolved*, in the affirmative, and the bill sent to the senate.

On motion by Mr. John P. Kennedy the following order was read and dissented from.

*Ordered*, That Mr. Purviance, of the city of Baltimore, be authorised to record his vote in favor of the bill relating to civil rights, in pursuance of the request made for him by his colleague, provided that he makes his application as soon as his present sickness enables him to attend the house.

Mr. Semmes presents a petition from the President and Directors of the Planters Bank, and other citizens of Prince-George's county praying that said bank may be permitted to issue bank notes of a smaller denomination than five dollars; read and referred to Messrs. Semmes, Thomas Kennedy, John P. Kennedy, Stonestreet and Steele.

Mr. Semmes reports a bill, entitled, 'an additional supplement to the act, entitled, An act to regulate the inspection of tobacco.

And Mr. Thomas reports a bill, entitled, An act relating to the public roads in the counties therein mentioned; which were read.

On motion by Mr. Thomas Kennedy, *Ordered*, that the bill to provide a revenue for the support of the government of this state, have a second reading on the 28th inst.

On motion by Mr. Allen, *Ordered*, that the bill relative to withdrawing the donation from colleges and academies, have a second reading on the 31st instant.

The clerk of the senate delivers the bill authorising the establishment of a ferry over Potomac river, from the lands of George Lafever, in Washington county, opposite the place called the Falling Water, in Virginia, endorsed "will pass." *Ordered* to be engrossed. The bill to alter, and change a road in the village of Denton, in Caroline county, endorsed "will not pass."

And the bill supplementary to the act, entitled, An act to incorporate the managers of the Black Creek School, endorsed "will pass with the proposed amendments;" which amendments were read.

On motion by Mr. John P. Kennedy, the following orders were read:

*Ordered*, That a list of the orders of the day be printed and laid on the desks of the members.

*Ordered*, That the bill for the removal of allegations against insolvent debtors from one county to another, have a second reading on the 29th instant.

Mr. Boon delivers the following reports:

The committee to whom was referred the petition of sundry inhabitants of Greensborough, and its vicinity, in Caroline county, for a repeal of the law to prevent swine and geese from going at large in said village, beg leave respectfully to report, That they have had the same under consideration, and are of opinion that the said law should not be repealed, and that the petitioners have leave to withdraw their petition.
