tion, and inserting the following: "Provided always, that nothing in this act contained shall be so construed as to grant to the company, established by this act, the exclusive right to the waters of the river Potamac; and that no company hereafter to be established by this state, or the state of Virginia, shall draw from the said river or canal, so much of the water thereof as shall render useless, or in any manner impair the canal or works to be constructed by the company hereby created, and the said states do hereby expressly reserve to themselves the right of intersecting or joining the said canal, any time hereafter, by any cross canal or canals, which there may think proper to authorise, the said right to be exercised in such manner as to do no injury to the canal or works as aforesaid.
