Oliver, of the city of Baltimore, & can see no good reason for changing the vote they heretofore gave on it. If this bill were to pass, we think the state might as well at once relinquish all its escheat property. Mr. Oliver is, we learn, fully able to pay the amount of the states' claim to the land mentioned in the bill.

In no cases that we know of, has the state relinquished its right to property of this sort ex-

cept under peculiar circumstances, and we see none such in the case before us.
