The agent for this shore conceived that the act of 1821 under which he was appointed authorised him to collect & charge a commission on nearly all the current revenue of the state on this shore. The senate are convinced that such a construction of the act in question is erroneous and with a view to put the question beyond doubt so far at least as they can by amending the resolution submitted to them, they have amended it, so as to limit the commissions of the agents to debts which were due the state at the passage of the act of 1821, chap. 190, and collected through their exertions.
