necessity of causing the proceedings of our house to be printed for the daily information of its members. We have found such aids important to all but more especially to those of our members who are necessarily absent from the house. For these reasons we have authorised the committee of claims to inquire into the actual cost of such printing, and have been informed by their report, that the joint cost of printing the daily journals, and fourteen hundred copies of the Votes and Proceedings of both Houses, will not exceed eight hundred dollars. With this information in our possession, we now propose a conference with a committee to be appointed on the part of your house, and for this purpose we have nominated Mesirs. M. Mahon, Carroll, and John Edelen, as a committee to confer with the committee to be appointed on the part of your house, on the propriety of causing them to be printed.

Mr. MeMahon obtained leave to bring in a bill, entitled. An act for the relief of James Melntire, a convict prisoner in the gaol of Allegany county. Ordered, That Messrs. M. Mahon, Hoffman and Klipstine, report the same.

The house adjourns until Monday morning 9 o'clock.
