Mr. Merrick moved to strike out the word "cannot" in Mr. Carroll's message? Resolved in the affirmative

The question was then put on the message proposed by Mr. Carroll, as amended? Determined in the negative.

Mr Duvall moved the following message:

We have received your message proposing a recess, and beg leave to propose a conference by a joint committee on that subject, and have named Messrs. Duvall, John Edelen and Wilson, a committee on the part of this house.

Ordered, That the bills to change the time of the meeting of the general assembly, have a second reading on the 17th January.

On motion by Mr. Merrick, Ordered, That the bill continuing expiring laws, have a second reading on the 3d Monday of January, 1825.

On motion by Mr. Lee, the following message was read

BY THE HOUSE OF DELEGATES. December 17, 1824.

Gentlemen of the Senate,

The serious injuries sustained on the part of the citizens of this state from the encouragement given to absconding negroes, by a portion of the citizens of Pennsylvania, in despite of the remonstrances repeatedly made through the executive branch of our government, and those of the committee appointed by the legislature, do in our opinion require, that we should again, and in a more impressive manner, call the attention of our sister state to the enactment of more rigorous, and we hope more successful regulations on their part, to effect justice to our fellow citizens. To this end we propose, that a joint committee consisting of members of each house, shall proceed to the seat of government of Pennsylvania, there to secure as far as practicable, by legislative provisions, a protection of the persons as well as the property of our tellow citizens.
