Resolved by the senate and house of delegates of Maryland, That the governor and council appoint a commissioner, whose duty it shall be to repair to the seat of government of Pennsylvania, and negotiate with such persons as may be appointed on the part of Pennsylvania, and make such arrangement as may be most convenient to the citizens of Maryland, in recovering their slaves abscending to the state of Pennsylvania.
