By order, The speaker laid before the house a communication from the clerk to the commissioners of the tax for Anne Arundel county, exhibiting a statement of the number of acres of land in said county, and the value thereof per acre, together with the amount of personal property assessed therein; as also the amount of real and personal property in the city of Annapolis according to the latest assessment; in pursuance of a resolution passed at December session 1824, No 41;

Which was read and ordered to lie on the table

On motion by Mr. Worthington, the following order was twice read and adopted; Ordered, That the examiner general report, forthwith to the house, the amount of fees received by him in his office, for the two last years, distinguishing the amount of fees for each year, ending on the first day of December 1824. Mr Dalrymple presents petitions from John Goodwin, and James Avis, of Calvert county, severally

praying for support; referred to the standing committee appointed on that subject.

Mr. Speed presents a petition from Dolly Terry, of Anne Arundel county, praying for support; referred

to the standing committee appointed on that subject.

On motion by Mr. Montgomery, leave was granted to bring in a bill, entitled, An act directing that the sense of the people of this state be taken on the expediency of calling a convention to reform the constitution, and for other purposes. Ordered, That Messrs. Montgomery, Beckett, Norris, Lee and Tyson, report the same.
