the laws respecting runaway negroes; referred to Messrs. Worthington, Shower and Howard.

Mr. Henderson presents a petition from John S Massitt, of Ceeil county, praying to be refunded money paid the state for land for which he obtained no title; referred to Messrs. Henderson, Thomas and Ewing. On motion by Mr. Thomas, Ordered, That the committee of ways and means be instructed to inquire into the expediency of reducing the number of lottery commissioners from three to one, and to report

thereon to this house

Gentlemen of the Senate,

We return you the bill, entitled, An act to ascertain and fix the salary of the clerk of the council, which was rejected by your honourable body on the 5th instant, with a full hope, that on mature reflection, you

will reconsider and pass the same.

On motion by Mr Dalrymple, Ordered, That the executive be requested to communicate to this house, as far as they can ascertain, the quantity of wood annually purchased for the legislature, and that department, as also the terms on which such purchases are made, and whether any part of said wood is consumed by any other of the departments of the government, if so, by whom, and on what authority, and any other information relative to the fuel and its consumption, which they may be enabled to communicate.

Mr. Steele delivers the following report:

The committee to whom was referred the petition of Frances Baker, of Dorchester county, for a law to authorise her to open a certain road therein mentioned, report unfavourably on said petition, on the ground, that the act of assembly of last session, chapter 73, fully provides for this case, and gives the levy court of Dorchester county fully and explicitly all the power necessary to enable them to hear and decide on this case. They respectfully recommend, therefore, that the petitioner have leave to withdraw her petition

Which was concurred with.

Mr Kemp presents a petition from Elizabeth Bryor, and Mr. Carroll a petition from Catharine Plane; referred to the committee on pensions and revolutionary claims.

Mr. Millard delivers the following report:

The committee to whom all divorce petitions were referred, have had the petition of Ann Isett, of Fre. derick county, under consideration, and are of opinion, that the said Ann Isett's situation requires legislative aid; they therefore beg leave to offer the accompanying hill.

And a bill, entitled, An act for the relief of Ann Isett, of Frederick county.

Ordered, That the hill to prescribe the time which jurors shall serve in Baltimore county court, have a second reading on the 8th instant.
