

VOTES AND PROCEEDINGS

Mr. Eccleston reports a bill, entitled, An act to limit the number of justices of the peace in the several counties of this state.

Mr. Maxcy delivers the following report:

Mr. Spencer presents a petition from Nathan Porter, of Talbot county; referred to the committee on pensions and revolutionary claims.

On motion by Mr. Peach, Ordered, That the treasurer of the Western Shore report to this house, as early as practicable, the number of hogsheads of tobacco inspected in the county warehouses on the Western Shore during the last year

The bill to repeal an act preventing swine and geese from going at large in the town of Rockville, was read the second time, passed, and sent to the senate.

Mr. Lantz presents a petition from Peter Gebhart, of Allegany county, referred to the committee on pensions and revolutionary claims.

The bill for the relief of Ann Issett, was postponed until Monday next.

Mr. Lantz obtained leave to bring in a bill authorising the valuation of real and personal property in Allegany county. Ordered, That Messrs. Lantz, M. Mahon and Klipstine, report the same.

Mr. Tyson presents a petition from William Patterson, and others, merchants of Baltimore, praying an alteration in the laws respecting pilots, referred to Messrs. Tyson, Howard, Gantt, J. Edelen and Millard.
