After an examination of the important matter of this reference, the committee conceive that the most immediate and efficient relief will result from the creation o' a limited emission of public currency. substantially founded on the real estate, and represented by solid value; and they also conceive that under proper regulations thereby the various interests of the state may be ameliorated, that industry in every department may be stimulated, and that those resources, which the want of an adequate supply of circulas ing medium have depressed and paralised, may be brought into full activity and beneficial operation. And they further conceive, that these objects may be achieved without infringing the just rights of any party, or in the least impairing the public security, or violating in any wise, the constitution of the federal government.

In the construction of a hill for this purpose we propose—I A financial committee to be appointed by the legislature, and commissioned by the governor and council, to prepare the money and control the

subordinate concerns of the institution.
