The bill relating to the trustees of the poor of Kent county was read the second time. On motion by Mr. Wilson, the same was so amended as to extend its operation to the several counties in this state,

The bill was then passed and sent to the senate.

The resolutions in favour of Spedden Orem, Michael Wakman and Thomas Townsend, were read the second time and assented to.

The resolution in favour of Lethe Willis, was read the second time.

On motion by Mr. Merrick, the following was added to the same: "And that the said allowance shall commence from the date to which her husband's pension has been paid up."
