Mr. Teackle reports a bill, entitled, An act for the relief of certain literary institutions.

Mr. Shower reports a bill, entitled, An act to lay out and make

public a road in Baltimore county.

Mr. Turner obtained leave to bring in a bill, entitled, An act relative to the appointment of inspectors and guagers of domestic spirits, and other liquors, their duties, and for other purposes. Ordered, That Messrs. Turner, Merrick, Howard, McCulloh and Thomas, report the same.

On motion by Mr. Sudler, the following order was read:

Ordered, That the board of commissioners of the school fund for Queen-Anne's county appointed in conformity to the act of the general assembly passed December session 1818, chapter 116, are requested to effect a meeting of said board, and report to this house, on the first of February, or as soon thereafter as practicable, what steps, if any, have been taken to carry into operation the design of that law, and further requested to join with that report, information relative to the present state and condition of the most promising schools in different parts of the said county, for disseminating useful knowledge, morals and virtue.

The house adjourns until to-morrow morning 10 o'clock.

Thursday, January 5, 1826.

message in reply proposed by Mr. Lee, and severally assented to; the
blank being first filled up with Messrs. Lee and Goldsborough on the
part of this house. The message and resolution were sant to the senate.

Mr. Kennedy obtained leave to bring in a bill, entitled, An act granting to the commonwealth of Pennsylvania, the right to cut a canal from the Maryland line to the Potomac river. Ordered, That Messre.

Kennedy, Merrick and Kershner, report the same.

Mr. Williams obtained leave to bring in a bill, entitled, An act to repeal all such parts of the law as authorise attorneys, practising in the sourts of this state, to charge and collect legal fees. Ordered, That
