Mr. M'Culloh obtained leave to bring in a bill, entitled, An act to regulate the manner of obtaining, altering and closing public roads in Baltimore county. Ordered, That Messrs. M'Culloh, Shower and Turner, report the same.

On motion by Mr. Kilgour, Ordered, That the committee of grievances and courts of justice, be directed to inquire into the expediency and propriety of abolishing the chancery court, and of establishing district chancery courts in this state, and that they have leave to report by bill or otherwise.
