The house according to the order of the day, proceeded to ballot for a treasurer for the western shore; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that Gideon Pearce had twenty votes, Lewis Duvall had twenty votes, George Mackubin had twenty votes, Daniel Sprigg had four votes, Thomas Culbreth had five votes, and Philip Reid had one vote.

There being no election, the house proceeded to a second ballot; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that Lewis Duvall had 25 votes, George Mackubin had 21 votes, Gideon Pearce had 21 votes, Daniel Sprigg had 3 votes, and Thomas Culbreth had 1 vote.

There not being an election, the house proceeded to a third ballot; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that George Mackubin had 26 votes, Lewis Duvall had 23 votes, Gideon Pearce had 20 votes, and Daniel Sprigg had 3 votes.

Mr. Pearce's name being withdrawn, the house proceeded to the 4th ballot, the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that George Mackubin had 35 votes, Lewis Duvall had 31 votes, and

that Daniel Sprigg had 4 votes.

Daniel Sprigg being withdrawn, and there being no election, the house proceeded to the 5th ballot; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported that Goorge Mackubin had 40 votes, and that Lewis Duvall had 32 votes.

Whereupon resolved, That George Mackubin be, and he is hereby declared to be, elected Treasurer for the Western Shore of the state of Maryland.

On motion by Mr. Teackle, the following resolution was twice read:
By the House of Delegates, Feb. 2, 1826.

Resolved by the General Assembly of Maryland, That the treasurer of the western shore, elect, before proceeding to act in the office to which he has been elected, shall give bond in the sum of one hundred thousand dollars, in the manner and form prescribed by the act of November session 1801, chapter 66.

On motion by Mr. Merrick, the words "one hundred thousand" were

stricken out, and "two hundred thousand" inserted,

The resolution was then assented to.

The clerk of the senate delivers a letter from the honourable Jeremiah T. Chase, notifying his acceptance of the appointment of bank director.

And returns the resolution relative to the removal of the old meeting house, endorsed "assented to." Also the further additional supplement, to a supplementary act, entitled, An act for the recovery of small debts out of court, passed at December session 1824, chapter 138.

Also the bill to incorporate the president and directors of the Firemans Insurance Company of Baltimore, severally endorsed "will pass

with the proposed amendments;" which amendments were read.

Also the bill for the relief of Arthur Wise, endorsed "will not pass," And a bill, entitled. An act relating to evidence in civil cases, endorsed "will pass;" which was read.

The house adjourns until to morrow morning 10 o'clock.
