

The resolution in favour of Robert Stuart, was read the second time, and the resolution assented to, and sent to the senate.

On motion by Mr. Millard, the following resolution was read, assented to, and sent to the senate:

Whereas, by a resolution adopted by this house at its present session, the executive were requested to cause an antient building, called the Old Meeting House, to be removed beyond the limits of the public circle, with the least possible delay: And whereas, it now appears to this house, that an immediate removal of said building would occasion great individual injury; therefore,

Resolved, That the executive be requested to cause said building to be removed before the first day of November next.

Mr. Benjamin I. Jones, presents a petition from sundry inhabitants of Somerset county, praying that a part of the donation granted to Washington Academy, in said county, may be given to Salisbury Academy, in the Town of Salisbury; referred to Messrs. B. I. Jones, Teackle, A. E. Jones, Brown and Hopper.

On motion by Mr. Teackle.

Ordered, That the executive communication, with a resolution of the general assembly of Kentucky, disapproving of the amendment to the constitution of the United States, proposed by the legislature of Georgia, relative to the ingress of persons of colour into any of the United States, contrary to the laws of such state, be referred to the committee on so much of the executive communication as relates to the states of Delaware, Connecticut and Illinois.

On motion by Mr. Teackle, the following resolution was read and referred to the committee of ways and means:

Resolved by the General Assembly of Maryland, That the treasurer of the western shore be and he is hereby authorised and required, to liquidate the state's claim of \$1,197 against the Bank of Somerset, on the best practicable terms, at his discretion, and to receive the avails of such liquidation, subject to the appropriation of the legislature.

Mr. Mitchell obtained leave to bring in a bill, entitled, An act to authorise James C. Wilbourn, of Worcester county, to remove a negro girl into this state. Ordered, That Messrs. Mitchell, Parker and Samuel R. Smith, report the same.

Mr. Kilgour obtained leave to bring in a bill, entitled, A supplement to a bill, entitled, An act for the benefit of the infant heirs of John Cole, of Saint-Mary's county, deceased. Ordered, That Messrs. Kilgour, Millard and Gough, report the same.

Mr. M'Culloh reports a bill, entitled, An act to incorporate the trustees of the Washington Academy or school in Baltimore county.

Mr. Kilgour obtained leave to bring in a bill, entitled, A supplement to the act of 1793, chapter 43. Ordered, That Messrs Kilgour, Howard and Perry, report the same.

The bill to withdraw the donations from the West Nottingham and Elkton Academies in Cecil county, and for other purposes, was read the second time.

Mr. Montgomery moved to amend the same, by inserting the words "the education of the poor children," after the word "towards." Resolved in the affirmative.

Mr. Sappington moved that the bill lie on the table.
