The resolutions in favour of John Templeman, and Samuel Bradford, were severally read the second time, assented to, and sent to the senate.

The bill to revive and extend the provisions of an act to provide for the appointment of commissioners for the regulation and improvement of Snow Hill, in Worcester county, and for other purposes, was read the second time, passed, and sent to the senate.

Mr. Stevens obtained leave to bring in a bill, entitled, A supplement to the act for the benefit of Ann Rochester and Frances Rochester. Ordered, That Messrs. Stevens, Hopper and Cockey, report the same.

Mr. Gilpin reports a bill, entitled, An act to incorporate the Susque-

hannah and Elkton Turnpike Company.

Mr. Hughes reports a bill, entitled. An act relative to the school fund for Montgomery county, and to the education of poor children in said county.

Mr. Kennedy reports a bill; entitled, An act authorising the levy court of Washington county to repair or rebuild the bridge over the

Conocochesague creek, at Williams Port.

Mr. Kershner reports a bill, entitled. An act authorising the levy court of Washington county to levy a sum of money for the purpose of

repairing and rebuilding a bridge over Conococheague creek.

The clerk of the senate delivers a bill, entitled, An additional supplement to an act, entitled, An act to incorporate a company to make the several turnpike roads therein mentioned, passed at December session 1815, chapter 190, endorsed, "will pass;" which was read.

The amendments to the bill to incorporate the president and directors of the Fireman's Insurance Company of Baltimore, was read the

second time, assented to, and the bill ordered to be engrossed.

On motion by Mr. Thomas, Ordered, That the bill relative to insolvent debtors be the order of the day for Thursday next.

The bill for the relief of Lambert Beard, of Cecil county, was read

the second time, passed, and sent to the senate.

According to the order of the day, the house proceeded to the second reading of the bill to provide for the public instruction of youth in primary schools throughout this state.

On motion by Mr. Edelen, the house resolved itself into a committee

of the whole to consider the same. Mr. Edelen in the chair.

After sometime spent in consideration of the same, the committee rose, the speaker resumed the chair, when the chairman reported progress. On motion by Mr. Speed, the further consideration of the same was

postponed until Monday next.

The bill to authorise the orphans courts of this state to order the sale

of real estates in certain cases, was read the second time.

Mr. Speed moved to insert in the 1st section after the word "personal" the words "is exhausted and has proven insufficient." Deter-

mined in the negative.

On motion by Mr. Spencer, the question was put, That the words for if the said real estate be in its nature indivisible or not susceptible of division without loss or injury to the parties concerned to order the sale of the entire real estate of such deceased person, be inserted after the words "deceased persons," in the 1st section. Resolved in the affirmative. The question was then put, Shall the bill pass? Resolved in the affirmative.

The bill to enable purchasers to obtain possession of lands and premises sold by sheriffs, coroners and elisors, at public auction, was read

the second time.
