That there is no subject which is of more general interest to the people of the state, than the laws relating to the inspection of flour, and the principles which regulate the commercial dealings in the article; and the committee have been induced, from this circumstance, to give the matter referred to them that enlarged consideration which alone could enable them to present it fully to the notice of the house. farmer, the miller, and the shipper, are all deeply concerned in the promotion of the same object, to wit, a high and uniform standard of inspection, which would keep up the character of Maryland flour in fureign ports, and thus enable the shippers, (the competition amongst whom must of course keep up the price to give to the farmer and miller that remuneration for their labour, which a steady and active demand in foreign countries can alone justify.
