Mr. Thomas moved to strike out the word "the" to insert "any future" before the word "legislature," in the 6th section. Determined in the negative.

Sec. 7. And be it enacted, That the sum of four dollars per day be allowed to each and every of the said directors, as a compensation for the time they are actually occupied in the performance of the several duties enjoined upon them by this act; a certificate whereof shall be signed by the president of said board.

Mr. Eccleston moved to add the following: "which shall be in lieu of all other

compensation or allowance." Determined in the negative.
