That the judges of elections in the ninth election district of Baltimore county shall be, and are hereby authorised and required, to receive, on the first Monday of October next, ballots from the voters thereof, for the purpose of taking and ascertaining the opinion of the majority of the voters of said district upon the propriety of changing the place of holding elections in said district, which opinion shall be expressed on the ballots by the words "for removal to Peter Ulrick's" or "against removal;" and the same having been counted, a return thereof shall be made by the judges aforesaid to the clerk of Baltimore county, who shall forward the same to the next general assembly of Maryland; and it is hereby made the duty of the judges aforesaid, to cause several notices to be set up at the place of election, at the time of opening the polls, that such ballots will be received, which notices they shall keep up during the continuance of said election.
