Mr. Tyson moved to strike out the words "governor and," for the

purpose of inserting "mayor and," Determined in the negative.

Mr. Williams moved to insert the words "or oftener if necessary." after the words "annually thereafter," in the first section of the bill. Resolved in the affirmative.

Mr. Tyson moved to insert the words "two of whom shall be citizens of the city of Baltimore at the time of their appointment," in the first section after the word "Baltimore." Determined in the negative.

Mr. Tyson then moved that the words, "and one for the city of Frederick," be inserted in the first section after the said word "Baltimore." Resolved in the affirmative.

The bill, amended as above, was then passed. The house adjourns until 6 o'clock, P. M.
