Arrange all reports and resolutions both of a public and private nature in the same manner.

The senate have received your message proposing an indefinite continuance of the session on account of unfinished business—whilst the senate are fully disposed to continue the session so long as the public good may require it, yet the senate are persuaded that unless some definite period is fixed upon for the close of the session, that by an additional accumulation of business it will be protracted beyond a period which will be either convenient to the members of the general assembly or conducive to the public good—The senate cannot therefore concur in your proposition, but are willing if it meets your convenience to continue the session until Saturday next.

A further supplement to an act empowering the levy court of Cecil county at their discretion to levy a sum of money to build a bridge over Octorara Creek, at or near Samuel Rowland's store, passed Dec. session 1824, ch. 6, was read the second time, passed, and sent to the senate.
