

Also the bill for the benefit of the heirs of John C. Ireland; the bill relating to the road lately located from Sharpsburgh, to Hager's Town, in Washington county; the bill to authorise the levy court of Frederick county to borrow a sum of money for the purposes therein mentioned; and the bill to provide for the purchase of the office papers formerly belonging to the surveyor's office of Frederick county, severally endorsed, 'will pass.' Ordered to be engrossed.

The supplement to the act, entitled, An act to incorporate the Savage Manufacturing Company; the bill relating to the public roads in Talbot county; the bill to authorise the trustees of the Lancaster and German School of Liberty Town, in Frederick county, to sell and convey the school-house, with the lot of ground attached thereto; the bill to confirm the proceedings of certain commissioners in Queen-Anne's county; the bill relative to granting licences to keepers of ordinaries in Prince-George's county, were read the second time, passed, and sent to the senate.

The clerk of the senate returns the bill for the promotion of internal improvement, endorsed 'will pass with the proposed amendments;' which amendments were read, assented to, and the bill ordered to be engrossed.

The bill to authorise the trustees of the poor of Kent county to purchase a farm or tract of land for the use of the poor, and to sell the present alms-house of said county, and for other purposes, was read the second time. Mr. Harris moved to strike out 'the trustees of the poor' to insert 'the levy court.' Determined in the negative. The bill was then passed and returned to the senate.

The clerk of the senate returns the resolution relative to Chester bridge, endorsed 'assented to.' And the supplement to the act to incorporate the Savage Manufacturing Company, endorsed 'will pass.' Ordered to be engrossed.

On motion by Mr. Barnes, the bill to revive an act authorising a lottery to raise a sum of money to purchase a fire-engine, and to erect pumps, in the Town of Easton, in Talbot county, was referred to the 1st of June next.

The bill for the relief of Alexander Hemphill, of the city of Philadelphia, was read the second time, and will not pass, and the bill returned to the senate.

Mr. Millard reports a bill, entitled, An act for the relief of Hannah Bostetter, of Washington county.

The bill for the relief of sundry poor persons in the several counties therein mentioned, and the bill to authorise the appointment of justices of the peace in the city of Baltimore with limited jurisdiction, were read the second time and amended.

Mr. Bowie and Mr. Dickinson from the senate, inform the Speaker, that the Governor is attending in the senate to sign and seal the engrossed bills, and request his attendance, with that of the members of this house, for that purpose.

The Speaker left the chair, and attended by the members of this house went to the senate chamber, and there presented the engrossed bills from No. 124 to No. 161, inclusive, to the Governor, who signed the same, and affixed the great seal thereto, in the presence of both houses. The Speaker, with the members, returned and resumed the chair.

The house adjourns until to-morrow morning 9 o'clock.
