Mr. Thomas asked leave to bring a bill, entitled. An act to grant a divorce a vinculo matrimonii to Mary Snowden of Cecil county. Ordered, That the object of the leave asked for be re-

ferred to the standing committee on divorces.

Mr. Peach obtained leave to report a bill, entitled, An act relating to the public roads in Prince George's county. Ordered, That Messrs. Peach, Du Val and Gantt, prepare the same.

Mr. Wright obtained leave to report a bill, to be entitled, An act to repeal an act, entitled, An act to exempt the servants of overseers of the county roads in Dorchester county. from doing duty on said roads, passed at December session 1824, and for other purposes. Ordered, That Messrs. Wright, Geldsborough and Rauleigh, prepare the same.
