son "who shall be commissioned by the governor, on the joint recommendation of the senate and house of delegates," to the vacant office of register of wills for each of the counties of Washington and St. Mary's,) and report the result, accordingly reported, that Daniel Schnebly was unanimously elected to the vacant office of the register of wills for the county of Washington; and that Enoch J. Millard was duly elected to the vacant office of the register of wills for the county of St. Mary's. Whereupon, Resolved, That Daniel Schnebly and Enoch J. Millard be, and they are hereby, respectively, recommended to his excellency the governor of Maryland, to be commissioned, the former as register of wills for Washington county, and the latter as register of wills for St. Mary's county.

Mr. Price presented a petition from Nathan Fitzpatrick, a soldier of the revolution, praying a pension; read and referred to the standing committee appointed on that subject. And also a petition from Elizabeth Blakely, formerly Elizabeth Cross, of Baltimore county, praying for a divorce; read and referred to the standing committee on that subject.
