Operative in Queen Anne's County passed at January Session of General Assembly of Maryland, Session of 1900

CHAPTER 64.

AN ACT to amend the Acts of Assembly 1874, Chapter 453, as also the Acts of Assembly 1888, Chapter 169 by adding two new sections thereto to be known as Section 7

WHEREAS, The Act of eighteen hundred and seventy-four, chapter four hundred and fifty-three, entitled an act to enable the qualified voters of Queen Anne's, Caroline, Dorchester and Talbot counties, to determine her. letermine by ballet whether spirituo or fermented liquors should be sold in said counties or any election district thereof, was at an election held in pursuance there-of, adapted by a majority of the legal vo-ters of the Fourth Election district of

nor in the amendment is the prohibited : and whereas the sale of Cider is conducted contrary to the wishes of a majority of the voters of said district, to the great disturbance of peace, quiet and order as well as to the injury of the business interests of said district; and Wheneas petitions have been addressed to the General Assembly for an amendaforv act to remedy the grievances com-

plained of and growing out of the said planted of and glowing bar of the saut sale of cider; therefore,
Sec. 1. Be it enacted by the General Assembly of Maryland, that said act of the General Assembly of Maryland of the January session eighteen hundred and seventy-four, chapter four hundred and ifty-three, and amended at the January session of eighteen hundred and sixty-nine, be and the same is hereby amended so far as the same relates to the Fourth Election district of Queen Anne's county by adding the two following sections to be numbered seven and eight,
Sec. 7. That the terms and provisions of said Acts of Assembly be and the same are hereby amended, enlarged and extended, so as to embrace and include therein the prohibition of the sale of intoxicasale of cider : therefore
