

WASHINGTON LETTER.

Some News Collected at the National Capital by Our Regular Correspondent.

WASHINGTON, March 31, 1902.—No event in the history of the Fifty-seventh Congress has produced the consternation that was occasioned on Thursday when Representative Richardson of Tennessee, in a question of privilege and introduced a series of resolutions reciting that a Captain Charles Christmas, a quagman of the Danish government, had in a secret report to his government, stated that he had, as a promoter of the treaty conveying the Danish West Indies to the United States, pledged bribes to the amount of 10 per cent of the purchase price to effect the sale to this country.

Richardson's resolutions further called for the immediate appointment of an investigating committee. As the clerk proceeded with the reading of his resolutions a number of the members are said to have turned pale and there was intense excitement in the chamber. Representative Bayne claimed that the resolutions were not in order and Representative Cannon protested against immediate action but Speaker Henderson ruled that the point of order was not well taken and finally the resolutions were reported and an investigating committee Wednesday afternoon three democrats and four republicans was appointed.

Speaking of the subject later, Richardson told me that he knew nothing as to the correctness of Christmas' assertions but he believed the matter was of sufficient importance to warrant its being brought to the bottom. He criticized Secretary Hay for not having called the attention of Congress to the report before, so that it might be investigated and reported before the ratification of the treaty. "The honor of Congress is at stake," said Richardson, "and if this thing is a tissue of slanders that is all the more reason why it should be so soundly thrashed."

Mr. G. B. Hays, a democratic senator, speaking on the subject, said: "I do not believe that any member of the Senate has permitted himself to be bribed. However, Christmas' statement shows that he approached very near the fountain head of certain legislation. His statement that a magazine of the Standard Oil Company claimed that he could control the votes of twenty-six senators is not new. That these things are done by bribing is not true, but that great corporations influence legislation, is unfortunately far truer than it should be. The general extravagance of Christmas' allegations is demonstrated, however, by his statement that Senator Lodge is the only man in American political life who will not take a bribe. That is a statement of sense! I anticipate that the investigation will demonstrate Christmas' as an unprincipled adventurer who may or may not have expended money along lines which he believed would influence legislation. The one grave error in the affair seems to me to have been made by Secretary Hay in having any dealings with a man who was not only not properly accredited but who had not even an introduction from the Danish minister."

In reply to a question, Mr. Hay said: "My respect for the late President precludes my expressing myself in regard to Abner McKinley." During the first four days of the past week the Senate discussed the anti-obscenities bill and Thursday evening it adjourned until the following day, when the same bill will be "regularly order." The spirit of rebellion against the dictatorship which Speaker Henderson has been exercising in the House has extended to the Senate and the latter body has today a republican senator told me that if the Speaker continued to suppress certain measures which had been passed by the Senate the latter body might conclude to reconvene the bills and attach them to some of the appropriation bills sent over from the House. This is particularly true of the Ship Subsidy bill and the irrigation bill, both of which the Speaker apparently intends to bury in committee and both of which are likely to reappear attached to the River and Harbor bill when the Senate sends it to conference. The democrats are rather enjoying the discomfiture of the republicans under the Speaker's tyranny, from which they have so long suffered and so ineffectually protested against.

The democrats are also getting some amusement out of the friction which has developed between the Senate Philippine committee and the House committee on Insular Affairs. The former has determined to recommend a silver standard for the islands while the House committee holds out for a gold standard. That the republicans themselves, after their extravagant claims in regard to the benefits to be derived from the gold standard, should find themselves divided on such a question is one of the inconsistencies for which that party is noted.

The minority of the Philippine committee will propose to the Senate a plan which has determined to depend on the Philippines as soon as the President can proclaim that the insurrection is ended. The \$20,000,000 which the United States paid for the islands is to be paid back to this government and the United States is to secure, by treaty, pledges from all foreign nations that the neutrality of the islands shall be preserved. This is the plan with which the democrats will confront Senator Lodge's imperialistic measure on the floor of the Senate.

At a meeting held on Friday evening "the committee of seven" of the Democratic National Committee, elected Representative Griggs, of Georgia, as chairman of the full committee, subject to ratification by the latter, which will, of course, follow. CONFERENCE OPENS.

Election of Officers Marks the First Day's Session of the Methodist Protestants.

The 74th session of the Maryland Annual Conference of the Methodist Protestant Church convened at Grace M. P. Church, Centerville, Wednesday morning, Dr. S. B. Southernland was called to the chair, and President A. D. Melvin read his annual report, it being the fifth one to be made by him.

The report showed that the conference was in a healthy condition both spiritually and financially. At 10:45 o'clock Rev. J. M. Sheridan preached the conference sermon.

At the afternoon session the first business was the election of officers. Rev. B. E. Kindlay and Chas. Dodd were appointed tellers. The vote was taken by ballot, when Dr. F. T. L. received 129 votes, Dr. Walter Graham 17 votes, Dr. Targg, 13 votes, Rev. J. Sheridan 15 votes, Rev. J. M. Holmes, 1 vote, Rev. J. T. Lassell 1, H. L. Elderdie, A. W. Mather, J. S. B. Treasday, L. Dr. Little was declared elected president and duly installed by the outgoing president, Dr. Little thanked the conference for the honor and pledged himself to conduct the office to the best of his ability.

The vote for secretary was then called for, when Dorsey Blake, the present incumbent, and W. S. Phillips, were put in nomination, resulting in the election of Phillips, he receiving 104 votes and Blake 64. Rev. T. R. Woodford was elected conference steward; E. S. Fookes, church extension steward; W. S. Litsinger, supernumerary fund steward; J. M. Dickey, educational fund steward.

The rest of the afternoon was consumed in discussing the publication of the minutes of the conference. Dr. T. H. Lewis presented a paper in which it was proposed to reduce the size and cost of the minutes by curtailing certain portions, namely, that of obituaries of ministers, also omitting the names of installed ministers, and several other items. The two named items were defeated, but most of the report was adopted.

The second day of the conference was occupied greatly with routine business, although at the afternoon session debate waxed warm for over two hours. It was caused by Rev. Holmes, of Baltimore, offering a resolution prohibiting ministers from serving one charge for more than five years. The discussion was particularly lively in quite a number of ministers, but no motion. At the recess Thursday night they were no way near a vote on the question.

In the morning a resolution was offered to let the president's personal and to pay him \$200 this year and let him rent a parsonage and furnish it at his own expense. This caused considerable discussion and was finally amended so as to pay the president this year \$250 and let him rent a suitable house and receive \$500 with which to furnish it.

A communication from St. John's Independent Church, Baltimore, was read, in which they asked the conference to loan them Rev. Frank T. Hanson, Chas. M. Howers, J. S. B. Treasday, and Joseph Ozmom and John Fried, of Centerville, under the direction of the organizer, Miss Catherine L. Havens, of Centerville, rendered Borde's mass.

EASTERN SHORE TRADE.

The Queen Anne's Railroad Will Connect the Trade with Balto., by new Charter.

The Baltimore American contained the following well timed editorial concerning the trade relations of the Eastern Shore with the State's metropolis and the effect which the Queen Anne's Railroad will have on the same:

"The enlargement of the charter privileges of the Queen Anne's Railroad is a clear proof that Baltimore capitalists are awakening to the importance of the Eastern Shore and its trade. Hitherto, Baltimore has been compelled to depend more or less upon a water navigation and a connecting link between itself and the Peninsula. As a consequence, the city was never in proper touch with the major portion of either the people or the Peninsula territory.

"The Queen Anne's Railroad has been for some time more closely identified with the Eastern Shore than Baltimore has. That has been due to the fact that the dominating railroad system down there has exploited the section for the benefit of the railroad and provided ready facilities for traveling and freighting northward, and has attached the various leading towns to its main stem in Delaware by a series of well operated branch lines.

"The Queen Anne's Railroad contemplates something which Baltimore capitalists propose to extend itself down the Peninsula so as to traverse all the most important part of the lower counties. By the construction of a main line and a sufficient number of short branches, the whole Eastern Shore will be embraced within the territory of the enlarged system. That will render possible the complete unloading of Eastern Shore interests to those of Baltimore. It will open up the needed chance to turn the current of trade from Philadelphia to Maryland's own metropolis.

"Local capitalists are taking considerable interest in the enterprise, because they are perfectly in the main much towards increasing the volume of business here. For too many years the patronage of a large and prosperous section has been permitted to empty itself into Northern markets. It is impossible to estimate the millions which in the past quarter of a century have been captured by Philadelphia which logically belonged to Baltimore. It is fortunate, therefore, that this city is preparing to claim its own.

"The Peninsula is now united by a network of telephons, with long-distance connections with Baltimore, and since an influx of capital to the Shore, along with the introduction of highly developed trucking methods have made the section more business than ever, it is wise, indeed, that the city which has so long been provided which will guarantee the future that the drift will be in this direction. The time is fast coming when Baltimore's prosperous men will be owners of some of the rich lands which are now sold down there, but which are also naturally endowed with many attractions for country homes."

MONEY IN POTATOES.

Maryland's Soil is Well Adapted to Raising Large Crops and Command Good Prices.

About this time of the year the farmer is thinking of his chance for crops. The autumn was fine weather, and as is usually the case in this latitude, and January was almost a perfect winter month. Many farmers took advantage of the good weather and prepared as far as was possible for spring and summer crops. But February was of such severity that work on the farm was an impossibility.

March temperature was below the freezing point every day, except on snow and ice covered everything. Since the break-up, with sleet and rain storms to impede him, the farmer can hardly be censured if he is disposed to be discouraged. There have been so many warm days that the sun and winds have not had sufficient scope to dry the ground, and the consequence is that the spring crops in this latitude will be late.

April is generally too cool for vegetables to make much progress and, if May should be unfavorable, especially rainy—as was the case last year—the farmer is apprehensive that the transition from the cool weather of spring to the heat of summer early in June will upset the delicate balance of early crops. The present outlook, however, is not so much favored as Maryland's soil is the farmer's hope of making a living, or at least, of coming out even. Last year, for instance, was so unfavorable for the early potatoes that the price in the Baltimore market was one time \$5 a barrel, and even higher in cities up North. The consequence was the growers who had crops made small fortunes. It is estimated that dealers paid the growers for potatoes alone over \$1,000,000. When it is considered that in ordinary seasons \$1 a barrel profit is considered a fair income, the gain to the farmers from one crop was considerable.

The early crops of vegetables, fruits and grains, and those with oysters, fish, crabs and stock as sources of income, make a living reasonably sure. In no season does it happen that there is a failure in all crops. Farmers in the West are buying more land every year and are producing evidence that they are the great advantage the State possesses in soils that can be improved, and especially in the low cost of transportation of produce, and the nearness of good markets.
