Carried in the negative.

Chase, the question was put, That the following be inserted as an article in the form of government; "That every person who shall offer to vote for delegates, or for the senate, or for the sheriff, shall (if required by any three persons qualified to vote) before he be admitted to poll, take such oath or affirmation of support and fidelity to this state, as this Convention or the legislature shall direct?" Resolved in the affirmative.

On motion of Mr. S. Chase, the question was put, That the following be inserted as an article in the form of government; "That a justice of the peace may be eligible as a senator, delegate, or member of the council, and may continue to act as a justice of the peace?" Resolved in the affirmative.
