Scott, That the following be inserted as an article in the form of government; That the electors of the senate immediately on their meeting, and before they proceed to the election of senators, take such oath of support and sidelity to this state, as this Convention or the legislature shall direct, and also an oath "to elect without favour, affection, partiality, or prejudice, such persons for senators as they in their judgment and conscience believe best qualified for the office." An amendment was proposed by Mr. Bayly, to insert the words "or affirmation" after the words "such oath." On which amendment the question was put, and carried in the negative.
