On motion, Resolved, That three persons be appointed a board to continue the books of accounts of the expenditure, loan, or disposition of all public monies, by or under the authority of the Convention, or Council of Sasety, opened by the late board, with power to audit, examine and adjust all accounts and sums of money due from or to this state, and that they transmit the same, with the respective balances struck, to this Convention when sixting, and in their recess to the Council of Sasety, for their examination and controul.

That the said commissioners, before they enter upon the execution of their trust, take an oath or affirmation, carefully and accurately to audit, examine and adjust all accounts and sums of money due from or to this state, and that they will not allow any claim against the public but what they in their judgment and conscience shall deem just and right; that they will keep just and true accounts, and will transmit the same, with the respective balances struck, to the Convention, or in their recess to the Council of Sasety, for their examination and controul; and that the said commissioners will keep seemet all such matters or things as come before them in the execution of their said trust, as they shall be enjoined to keep secret by the Convention or Council of Sasety.

RESOLVED, That there be a clerk to the said board of commissioners, and that the said clerk be allowed ten shillings for every day he shall attend such service, and that he take an oath before he enters on the execution of his office, that he will faithfully and truly enter all accounts, and make all such entries as he shall be directed by the said commissioners, and shall also take the oath of secrecy as above directed to be taken by he commissioners.

RED D. That Mr. John Davidson, Mr. Thomas Brooke Hodgkin, and Mr. William Wilkins, be appropriately amissioners for the said board, that any two of them have power to act, and that each of them be an thill as per day for their trouble for every day they shall attend such service.
