An ACT for confirmation of all proceedings, judicial, military and civil, from the death of his excellency Lyonel Copley, Esquire, their majesties late governor and captain-general of Maryland, &c. unto the arrival of his present excellency Francis Nicholson, Esquire, the present governor thereof. Lib. LL. No. 2. fol. 62. Repealed 1704, ch. 77. Passed 18th of October, 1695.

C H A P. VII.

An ACT ascertaining the expences of the delegates of assembly, and commissioners of the provincial and county courts. Lib. LL. No. 2. fol. 66. Repealed 1704, ch. 77.

C H A P. VIII.

An ACT for erecting Anne-Arundel and Oxford towns into ports and towns. Lib. LL. No. 2. fol. 69.

C H A P. IX.

An ACT empowering Richard Bishop, of Talbot county, brother and heir of William Bishop, late of Talbot county, deceased, to sell and dispose of so much land as will amount to fifty thousand pounds of tobacco, for the payment of the charges expended in recovering of the said estate. Lib. LL. No. 2. fol. 76. A Private Act.

An ACT for tonnage, and ascertaining naval officers fees. Lib. LL. No. 2. fol. 79. Repealed 1704, ch. 77.

C H A P. XI.

An additional act to the act for quieting possessions. Lib. LL. No. 2. fol. 79. Repealed 1704, ch. 77.

C H A P. XII.

An additional act to the act for religion. Repealed 1695, ch. 1.

C H A P. XIII.

An ACT for settling a revenue on their majesties present governor. Expired.

C H A P. XIV.

An ACT for appointing rangers for the defence of this province. Repealed 1695, ch. 23.

C H A P. XV.

An ACT confirming the acts of the last session of assembly of this province, now remaining upon record in the secretary's office, to be the body of laws, until the same shall arrive from England.

C H A P. XVI.

An ACT for reviving the temporary laws of this province.   
 Viz. 1693, ch. 12, 26, 28, 33, 34, 45, 46, 53, 54, 55, 61, 68, 77, 79 and 82, all which are hereby continued for three years, or to the end of the next session, &c. Expired.

C H A P. XVII.

An ACT for repealing certain laws of this province.

C H A P. XVIII.

An ACT for appeals, and regulating writs of error.   
 For three years, or to the end of the next session. Continued 1695, ch. 16. Expired.

C H A P. XIX.

An ACT for the imposition of four-pence per gallon on liquors imported into this province.   
 For three years, or to the end of the next session. Continued 1695, ch. 16. Expired.

C H A P. XX.

An ACT to prevent the great evil occasioned by the multiplicity of horses within this province.   
 For three years, or to the end of the next session. Continued 1695, ch. 16 and 26. Expired.

C H A P. XXI.

An ACT for regulating ordinaries, and limitting the number of them within this province.   
 For three years, or to the end of the next assembly. Expired.

C H A P. XXII.

An ACT prohibiting the inhabitants of this province, or any others, from carrying liquor to the Indian towns and cabins.   
 For three years, or to the end of the next session. Continued 1695, ch. 16 and 26. Expired.
