At a SESSION of ASSEMBLY, begun and held at the TOWN and PORT of ANNAPOLIS, on the 28th day of June, in the 11th year of the reign of our Sovereign Lord WILLIAM the third, by the Grace of God, of England, Scotland, France and Ireland, King, Defender of the Faith, &c. *annoque domini 1699*, and ended the 22d day of July following.

An ACT for stay of executions after the tenth day of April, yearly. Lib. LL. No. 2. fol. 183.
Repealed.

C H A P. IX.

An ACT empowering the vestrymen to assess their parishioners for finishing and repairing of
churches. Lib. LL. No. 2. fol. 185.
