

Passed 22d of July, 1699.

C H A P. XI.
An ACT for the more speedy conveying the public letters and packets of this province, and settling a revenue on the sheriffs for defraying the charge thereof. Lib. LL. No. 2. fol. 192. Repealed.

C H A P. XII.
An ACT empowering the commissioners of the county courts to levy and raise money to defray the necessary charges of their counties. Lib. LL. No. 2. fol. 196. Repealed.

C H A P. XIII.
An ACT for the marking highways, and making the heads of rivers, creeks, branches and swamps, passable for horse and foot. Lib. LL. No. 2. fol. 197. Repealed.

C H A P. XIV.
An ACT concerning the height of fences, and to punish burners thereof, and also to restrain the multiplicity of horses and mares, &c. Lib. LL. No. 2. fol. 201. Repealed.

C H A P. XV.
An ACT for the killing of wolves. Lib. LL. No. 2. fol. 203. Repealed.

C H A P. XVI.
An ACT to enable the purchasers of the subscriptions to the free-school to recover the same. Lib. LL. No. 2. fol. 205. A Private Act.

C H A P. XVII.
An ACT for settling a revenue on his majesty's present governor. Lib. LL. No. 2. fol. 206. Expired.

C H A P. XVIII.
An ACT ascertaining the bounds of land. Lib. LL. No. 2. fol. 207.
N. B. This act fell under the general repeal of 1704, ch. 77, but by ch. 98, of that year, was revived and continued till the end of the next session. It was in like manner revived by 1705, ch. 10, and 1706, ch. 1, and totally expired on the 15th April, 1707.

C H A P. XIX.
An ACT for settling assemblies and provincial courts at the Port of Annapolis, in Anne-Arundel county. Lib. LL. No. 2. fol. 227.

Assemblies, &c. to be held at Annapolis.

BE IT ENACTED, by the King's most excellent majesty, by and with the advice and consent of this present General Assembly, and the authority of the same, That the Port of Annapolis, in Anne-Arundel county, be the chief place and seat of justice within this province, for holding assemblies and provincial courts.

Writs where returnable.

II. AND, That all writs, pleas and process, issuing, or that has issued out, and returnable to the provincial as aforesaid, or to the court of chancery, shall, from the end of this present sessions of assembly, continue and be made returnable to the Port of Annapolis, in Anne-Arundel county aforesaid.

C H A P. XXI.

C H A P. XXII.
An ACT for continuing the late act for imposing three-pence per hoghead upon tobacco, to the use of his present excellency, from the time of his arrival here to the end of this session of assembly. Lib. LL. No. 2. fol. 232. Expired.

C H A P. XXIII.
An ACT for raising a supply towards the defraying of the public charge of this province, and to prevent too great a number of Irish papists being imported into this province. Lib. LL. No. 2. fol. 233.
