An ACT for the more speedy conveying of public letters and packets of this province, and defraying the charge thereof. Lib. LL. No. 3. fol. 118. Repealed 1710, ch. 2.

C. H. A. P. XLVI.
An ACT for the recording of all the acts of assembly of this province in the secretary's office, as also transmitting of the journal of the house of delegates into the said office. Lib. LL. No. 3. fol. 120. Repealed 1715, ch. 49, and 1719, ch. 16.

C. H. A. P. XLVII.
An ACT for the punishment of blasphemy, profane swearing and cursing. Lib. LL. No. 3. fol. 122. Repealed 1715, ch. 49, and 1719, ch. 16.

C. H. A. P. XLVIII.
An ACT against engrossers and regraters. Lib. LL. No. 3. fol. 124. Repealed 1774, ch. 3.

C. H. A. P. XLIX.
An ACT for the stay of execution after the tenth of May, yearly. Lib. LL. No. 3. fol. 127. Repealed 1715, ch. 49, and 1719, ch. 16.

C. H. A. P. L.
An ACT for killing of wolves and crows. Lib. LL. No. 3. fol. 128. To continue for two years. Expired.

C. H. A. P. LVIII.
An ACT for ascertaining the bounds of a certain tract of land to the use of the Nanticoke Indians, so long as they shall occupy and live upon the same. Lib. LL. No. 3. fol. 144.
