C H A P. XIII.

An ACT repealing an act, entitled, * An act to prohibit the exportation of European commodities out of this province: Lib. LL. No. 3. fol. 300.

C H A P. XIV.

An ACT to continue to the sheriffs of Talbot, Kent, and Cecil counties, power of execution for public dues and officers fees within the present bounds of their several counties after the first of May next till the last of June next after, or until their several commissions expire, which shall first happen. Lib. LL. No. 3. fol. 300. Expired.

C H A P. XV.

An ACT to prevent cropping, cutting and defacing tobacco taken on board ships and vessels upon freight. Lib. LL. No. 3. fol. 302. Dissent.

C H A P. XVI.

A Supplementary act to the * act for advancement of trade, and erecting ports and towns. Lib. LL. No. 3. fol. 305. Dissent.

C H A P. XVII.

An ACT for relief of debtors, and ascertaining the manner of tenders in tobacco. Lib. LL. No. 3. fol. 322.

To continue for three years. Revived 1710, ch. 15. Expired.

C H A P. XVIII.

An ACT for the killing of wolves and crows. Lib. LL. No. 3. fol. 326.

To continue for three years. Revived 1710, ch. 14. Expired.

C H A P. XIX.

An ACT reviving a certain act of assembly of this province, entitled, An act prohibiting the importation of bread, beer, flour, wheat, or other English or Indian grain, or meal, horses, mares, colts or fillies from Pennsylvania, and the territories thereto belonging, made at a session of assembly begun and held at the port of Annapolis, the fifth day of September 1704. Lib. LL. No. 3. fol. 328.

To continue three years, &c. The original act of 1704, ch. 43, was repealed 1715, ch. 49, and 1719, ch. 16.

C H A P. XX.

An ACT reviving an (a) act for speedy conveying public letters and packets of this province, and defraying the charge thereof, made at a session of assembly, begun and held at the port of Annapolis, the fifth day of September, 1704. Lib. LL. No. 3. fol. 328.

(a) 1704, ch. 45, hereby continued for three years.

C H A P. XXI.

An ACT reviving a certain act of assembly of this province, entitled, (b) An act of directions for the sheriff's office in this province, and for the more easy payment of the public and county levy, made at a session of assembly, begun and held at the port of Annapolis, the fifth day of September, 1704. Lib. LL. No. 3. fol. 329.

(b) 1704, ch. 15, hereby continued for three years.

C H A P. XXII.

An ACT appointing court days in Queen-Anne's county. Lib. LL. No. 3. fol. 330.

C H A P. XXIII.

An ACT requiring the agents of the lord Baltimore, to certify into the secretary's office the instructions and conditions of plantations, with the fees by them demanded, and obliging his lordship's deputy-surveyors to qualify themselves according to law. Lib. LL. No. 3. fol. 331.

C H A P. XXIV.

An ACT to empower certain persons therein named to assess and apportion the public levy of this province for this present year of our Lord one thousand seven hundred and seven. Lib. LL. No. 3. fol. 333.
