At a SESSION of ASSEMBLY, begun and held at the CITY of ANNAPOLIS, in the county of Anne-Arundel, the 28th day of October, and ended the 15th day of November, in the 11th year of the reign of our Sovereign Lady ANNE, Queen of Great-Britain, France and Ireland, Defender of the Faith, &c. *annoque domini* 1712, were enacted the following laws. 1712.

C H A P. I.  
 An ACT for relieving the inhabitants of this province from some aggrievances in the prosecution of suits at law. Lib. LL. No. 4. fol. 29. Passed 15th of Nov. 1712.

To be in force till the end of the first session of assembly after the arrival of a governor. Expired.

C H A P. II.  
 An ACT making valid and effectual in law a deed of bargain and sale made by colonel Ninian Beale, of Prince-George's county, to Michael Ashford, late of the same county. Lib. LL. No. 4. fol. 32. A Private Act.

C H A P. III.  
 An ACT restraining the inhabitants of this province from selling any quantities of strong liquors to the Indians, and to prevent spreading false rumours, inciting differences between them and her majesty's subjects of this province. Lib. LL. No. 4. fol. 34.
