For three years. Expired.

C H A P. XII.

An ACT for the relief of Henry Acton, of Prince-George's county, in making valid and effectual a certain deed of bargain and sale from Gilbert Clarke to John Bayne. Lib. LL. No. 4. fol. 94. A Private Act.

C H A P. XIII.

An ACT for killing of wolves, crows and squirrels. Lib. LL. No. 4. fol. 96. Repealed in part 1723, ch. 5, and totally 1728, ch. 7.

C H A P. XIV.

An ACT for the payment and assessment of the public charge of this province. Lib. LL. No. 4. fol. 98.

C H A P. XV.

An ACT for the relief of John Cole, of Charles county, carpenter. Lib. LL. No. 4. fol. 99. A Private Act.

C H A P. XVI.

An ACT for the naturalization of Stephen Rich, of Queen-Anne's county, carpenter, and his children, John Lamée, of Dorchester county, weaver, and his children, and Samuel Berry, of Kent county, carpenter. Lib. LL. No. 4. fol. 100. A Private Act.

C H A P. XVII.

An ACT reviving an act of assembly of this province, entitled, (a) An act prohibiting the importation of bread, beer, flour, malt, wheat, or other English or Indian grain or meal, horses, mares, colts or fillies, from Pennsylvania, and the territories theretobelonging. Lib. LL. No. 4. fol. 101.
