

1721. JULY. CHARLES LORD BALTIMORE.

At a SESSION of ASSEMBLY begun and held at the CITY of ANNAPOLIS, in the county of Anne-Arundel, the 18th day of July, in the 7th year of the dominion of the right honourable CHARLES, absolute Lord and Proprietary of the provinces of Maryland and Avalon, Lord Baron of Baltimore, &c. annoque domini 1721, were enacted the laws following.

C H A P. I.

Passed 5th of August, 1721. An ACT for reviving of an act, entitled, (a) An act for raising a duty of three-pence per hogshead on all tobacco exported out of this province, for the uses therein mentioned. Lib. LL. No. 4. fol. 516.

C H A P. II.

An ACT for reviving and continuing an act of assembly, entitled, (b) An act for relieving the inhabitants of this province from some aggrievances in the prosecution of suits at law. Lib. LL. No. 4. fol. 517.

C H A P. III.

An ACT reviving and continuing the (c) act for ascertaining the gauge and tare of tobacco hogsheads, &c. Lib. LL. No. 4. fol. 517.

(c) 1717, ch. 7, hereby continued till 29th September, 1723.

C H A P. IV.

1725, ch. 33. A Supplementary act to the \* act for stay of executions after the tenth day of May, yearly. Lib. LL. No. 4. fol. 518.

Repealed after 10th May, 1792, by 1791, ch. 67.

C H A P. V.

An ACT for the naturalization of Joseph Lazear, and Gustavus Hesslius, of Prince-George's county, and their children, and also Christian Geist, of the city of Annapolis, gentleman. Lib. LL. No. 4. fol. 520. A Private Act.

C H A P. VI.

An ACT to confirm the lands devised by Robert Anderson, of Prince-George's county, deceased, unto his three sons, Robert Anderson, Cuthbert Anderson, and James Anderson, in fee-simple, to them and their heirs and assigns for ever. Lib. LL. No. 4. fol. 521. A Private Act.

C H A P. VII.

An ACT empowering the justices of Prince-George's county to levy twelve pounds of tobacco per poll on all taxables within the said county, for the finishing their court-house and building a public prison for the use of the said county. Lib. LL. No. 4. fol. 522.

C H A P. VIII.

An ACT for preventing the making of trashy tobacco, and for the bettering the staple of this province. Lib. LL. No. 4. fol. 523.

To be in force three years, &c. Expired.

C H A P. IX.

An ACT relieving and freeing the inhabitants of this province, and others, removing their families from any other countries or colonies to settle and inhabit within this province, from paying the duties and impositions on negroes for any of their domestic slaves. Lib. LL. No. 4. fol. 526.

C H A P. X.

An ACT for the relief of John Connaway, of Anne-Arundel county, a languishing prisoner. Lib. LL. No. 4. fol. 528. A Private Act.
