C H A P. XXII.

Passed 23d of April, 1735. An ACT for applying the duty of three-pence per hoghead raised by the act therein mentioned. Lib. BLC. fol. 138.

C H A P. XXIII.

An ACT to enable the secretary of this province for the time being to record and enter up the proceedings of the provincial court, which were omitted to be done during the continuance of Vachel Denton in the office of clerk of the said court. Lib. BLC. fol. 139.

C H A P. XXIV.

An ACT for the taking out of the office of commissioners or trustees for emitting the bills of credit, the several sums herein mentioned, and for repaying the same into the said office by the several treasurers of this province. Lib. BLC. fol. 140.

C H A P. XXV.

Passed 24th of April, 1735. An ACT for defraying the public charge of this province. Lib. BLC. fol. 141.

1736. At a SESSION of ASSEMBLY begun and held at the City of ANNAPOLIS, the 20th day of April, in the 21st year of the dominion of the right honourable CHARLES, absolute Lord and Proprietary of the provinces of Maryland and Avalon, Lord Baron of Baltimore, &c. *annoque domini* 1736, and ending the 6th May following, the following laws were enacted.

C H A P. I.

Passed 6th of May, 1736. An ACT reviving and continuing an act of assembly of this province, entitled, (a) An act for the speedy recovery of small debts out of court before a single justice of peace. Lib. BLC. fol. 143.

(a) 1732, ch. 27, hereby continued three years, &c.

C H A P. II.

An ACT to continue an act, entitled, (b) An act for raising a duty of three-pence per hoghead on all tobacco exported out of this province for the uses therein mentioned. Lib. BLC. fol. 143.

(b) 1732, ch. 30, hereby continued till 29th September, 1739.

C H A P. III.

An ACT to continue an act of assembly of this province, entitled, (c) An act for the better relief of poor debtors. Lib. BLC. fol. 144.

(c) 1722, ch. 13, hereby continued three years, &c.

C H A P. IV.

A Supplementary act to the act, entitled, (d) An act for emitting and making current ninety thousand pounds current money of Maryland in bills of credit, and to restrain some evil practices of sheriffs under colour of the said act committed. Lib. BLC. fol. 145.

(d) 1733, ch. 6. This act to continue, in force three years, &c. and expired in 1740.

C H A P. V.

An ACT for continuing an act of assembly of this province, entitled, (e) An act to prevent cutting up tobacco plants, destroying of tobacco and tobacco-houses, and for ascertaining the punishment of criminals guilty of the said offences. Lib. BLC. fol. 146.

(e) 1732, ch. 8, hereby continued three years, &c.
