At a SESSION of ASSEMBLY, begun and held at the CITY of ANNAPOLIS, the 1st day of May, in the 29th year of the dominion of the right honourable CHARLES, absolute Lord and Proprietary of the Provinces of Maryland and Avalon, Lord Baron of Baltimore, &c. and ended the 4th day of June following, in the 30th year of his lordship's dominion, annoque domini 1744, the following laws were enacted.

C H A P. III.

An ACT for dividing St. Stephen's, alias North-Sassafras parish, in Geecil county. Lib. BLC.

By this act, it. From the end of this fession, all that part of St. Stephen's, alias North Sassafras parish, in Czeil county, lying within the following bounds, viz. Beginning at a certain place called Town Point, situated between Elk and Bohemia rivers, and from thence to run up Bohemia river to Middle Neck Point, from thence up Angustine creek, alias Little Bohemia, to Campbell's Branch, including all'Middle Neck, and the plantation of Charles Scott, and to the Cross paths, and from the Cross paths by a line drawn east to the exterior bounds of the old parish, and from thence by such metes and bounds as shall take in all that part of St. Stephen's parish which lies to the northward and westward of the before lines, so far as St. Stephen's parish extended to Elk river, and then by Elk river to Town Point aforesaid, shall be taken from St. Stephen's parish aforesaid, and be erected into a new parish, and called by the name of Augustine parish, and shall from the time aforesaid be deemed, &c. Augustine parish, and a part or parcel of St. Stephen's parish aforesaid, &c. a. The inhabitants of Augustine parish to enjoy all benefits, privileges, &c. in every respect equal with any inhabitants of any other parish in this province, with power to elect vestrymen, &c. 3. The chapel built on Bohemia manor to be reputed, deemed, &c. as the parish church of Augustine parish.

4. The reverend Mr. Hugh Jones to continue incumbent of both parishes during his life, &c.

An ACT for the speedy and effectual publication of the laws of this province, and for the encouragement of Jonas Green, of the city of Annapolis, printer. Lib. BLC. fol. 285.

## C.H.A.P.

An ACT to prevent the cutting up tobacco plants, destroying of tobacco and tobacco-houses, and for ascertaining the punishment of criminals guilty of the said offences. Lib. BLC. fol. 286.

THEREAS tobacco is the staple of this province, and that thereon depends the livelihood of Preamble. many of the inhabitants, as well as the most considerable branch of trade, and that it is as requifite that the property of the people should be as well secured in the fields, or open houses, as in their dwelling houses; it is therefore prayed that it may be enacted,

II. AND BE IT THEREFORE ENACTED, by the right honourable the Lord Proprietary, by and with the advice Penalty on perand consent of his lordship's Governor, and the Upper and Lower Houses of Assembly, and the authority of the sons cutting up same, That any person or persons who shall, after the end of this present session of assembly, cut or tobacco, &c. destroy, or cause to be cut up or destroyed, any tobacco plants belonging to any other person or persons, or by threats, menaces, or other similar means, shall cause or excite any person or persons to cut up or destroy any tobacco or tobacco plants belonging to any other person or persons, and shall be thereof convict by due course of law, shall forfeit and pay unto the party gridved one hundred
