## C H A P. V.

An ACT for laying out a road from the wind-mill and dwelling plantation of Nathaniel Manning, of Dorchester county. Lib. TBH. No. A. fol. 287.

Preamble.

WHEREAS Nathaniel Manning, of Dorchester county, by his petition to this general assembly, did set forth, that he resides in a neck upon Great Choptank river, about twelve miles distant from the town of Cambridge, in the said county, and within one mile of the main road that leads from said town to Edward Noel's, and that he hath begun a wind-mill, which, when finished, will necessarily draw a great number of carts and carriages; therefore prayed that an act might pass, to enable him to cut and make a road from the main road leading from Cambridge to Edward Noel's to your petitioner's dwelling plantation and wind-mill; and it appearing reasonable to grant said petition,

II. BE IT ENACTED, by the General Assembly of Maryland, That Robert Harrison, Edward Noel and Thomas Firman Eccleston, or any two of them, are hereby authorized to lay out a waggon road, twenty feet wide, from the said Nathaniel Manning's wind-mill and plantation until it intersects the main road leading from the town of Cambridge to Edward Noel's; which road, when made, shall be a public road, and kept up at the expence of the said Nathaniel Manning; that the commissioners aforesaid shall ascertain and value what damage such road running through any person's land shall amount to, which shall be paid to such person damaged by the said Nathaniel Manning.

## C H A P. VI.

An ACT for laying out a road from John Groff's mill, in Frederick county. Lib. TBH. No. A. fol. 288.

Preamble.

WHEREAS it is represented to this general assembly, by the petition of sundry inhabitants of Frederick county, that they labour under great inconveniencies for want of a waggon road from John Groff's mill, in Frederick county, until it intersects the road leading from Marsh creek to Baltimore-town, in Baltimore county, at Michael Dear's farm, about one mile below Piney creek, and also from the said mill until it intersects the road at Joseph Myer's farm, about three miles below Pipe creek; and it appearing reasonable to grant the said petition,

II. BE IT ENACTED, by the General Assembly of Maryland, That William Winchester, Thomas Durbin and Michael McGuire, or any two of them, are hereby authorized to lay out a waggon road, twenty feet wide, from the said John Groff's mill until it intersects the main road aforesaid leading from Marsh creek to Baltimore-town aforesaid at Michael Dear's farm, one mile below Piney creek, and also from the said mill until it intersects the main road aforesaid at Joseph Myer's farm, about three miles below Pipe creek, in Frederick county aforesaid; which said road, when made, shall be a public road.

Damage to be  
ascertained, &c.

III. AND BE IT ENACTED, That the commissioners aforesaid shall ascertain and value what damage such road running through any person's land as aforesaid shall amount to, which shall be paid to such person damaged as aforesaid by the said John Groff.

Not to go thro'  
orchards, &c.

IV. AND BE IT ENACTED, That the said road shall not go through any orchard, garden or meadow, unless with the approbation and consent of the owner.
