Preamble.

WHEREAS the extension of the navigation of Patowmack river, from tide water to the highest place practicable on the north branch, will be of great public utility, and many persons are willing to subscribe large sums of money to effect so laudable and beneficial a work, and it is just and proper that they, their heirs and assigns, should be empowered to receive reasonable tolls for ever, in satisfaction for the money advanced by them in carrying the work into execution, and the risk they run: And whereas it may be necessary to cut canals, and erect locks and other works on both sides of the river, and the legislatures of Virginia and Maryland, impressed with the importance of the object, are desirous of encouraging so useful an undertaking; therefore,

Books to be opened, &c.

II. BE IT ENACTED by the General Assembly of Maryland, That it shall and may be lawful to open books in the city of Annapolis, George-town and Frederick-town, in this state, for receiving and entering subscriptions for the said undertaking, under the management of Christopher Richmond and John Davidson, merchant, or either of them, at the city of Annapolis, William Deakins and Benjamin Stoddert, or either of them, at George-town, and Joseph Sim and Abraham Faw, or either of them,
