

county, and for other purposes, and to be collected in seventeen hundred and eighty-five, together with the money arising from the auctioneer's office in said town in seventeen hundred and eighty-five, shall be appropriated and applied to the purposes of this act.

C H A P.
LXIX.

By November, 1792, ch. 69, further taxes were directed to be levied, and that part of the act of 1792, was continued to the 30th of October, 1794, &c. by 1793, ch. 57, which directed the justices of the criminal court to levy the said tax. By 1795, ch. 30, the same part of the act of 1792 was repealed, and the justices were directed to levy, in lieu thereof, a sufficient sum on the assessable property.

XV. AND BE IT ENACTED, That the commissioners aforesaid, or a major part of them, shall appoint a treasurer, who shall be subject to the same rules and regulations as the treasurer appointed by the special commissioners of said town.

Treasurer to be appointed, &c.

XVI. AND BE IT ENACTED, That the comptrollers of said town are hereby authorized and required to ascertain what allowance the said commissioners shall be entitled to for the time employed in discharge of the several duties required by this act, which shall be paid in the same manner as the special commissioners are paid.

Allowance to be ascertained, &c.

XVII. AND, whereas the regulating the police of said town will be attended with very considerable expence, BE IT ENACTED, That, if the funds appropriated and applied by virtue of an act, entitled, An act for founding a college upon the western shore of this state, and constituting the same, together with Washington college on the eastern shore, into one university, by the name of The University of Maryland, shall be productive to the amount of the sum of one thousand seven hundred and fifty pounds current money, that then and in such case the surplus, if any, of the monies collected from Baltimore town for ordinary and retailers licences, shall be appropriated and applied to discharge part of the expences of this act.

Funds appropriated, &c.

XVIII. AND BE IT ENACTED, That the commissioners aforesaid shall return to the town clerk, from time to time, a just and true account, under their hands and seals, of the expenditures of all monies in virtue of this act, to be entered upon record amongst the proceedings of the said town, subject to the inspection of the town comptrollers, who are authorized to examine and approve or disapprove of the same, in the same manner as they are empowered by law to do with the special commissioners of the said town.

Account to be returned, &c.

XIX. This act to continue in force for three years, and until the end of the next session of the general assembly thereafter.

Duration.

Continued by 1787, ch. 38, for three years, &c. and by 1795, ch. 83, to 30th January, 1798; but it is declared by 1796, ch. 68, to be a perpetual law, subject to alterations, &c. to be made by the corporation or by the legislature, and by the same act the powers given by this and other acts are transferred to the corporation of the city of Baltimore.

An ACT to appoint an intendant of the revenue. Lib. TBH. No. A. fol. 536.

Passed 22d of Jan. 1785.

BE IT ENACTED, by the General Assembly of Maryland, That Daniel of Saint Thomas Jenifer, (who shall reside at Annapolis,) be appointed intendant of the collection and expenditure of the public assessment and revenue, and all monies and tobacco belonging to this state, for one year, to commence at the end of this session of assembly.

Intendant appointed, &c.

II. AND BE IT ENACTED, That the said intendant be authorized to inspect and take account of the public assessment and revenue, and all money, tobacco and other property, belonging to this state, and to take due care that the same be not destroyed, wasted, misapplied or embezzled, but managed and improved with the best economy, and to the utmost benefit of the public.

To inspect assessment, &c.

III. AND BE IT ENACTED, That the said intendant be empowered to superintend the collection of the public assessment now due, or to arise due, and to call on collectors thereof to render fair and full accounts of their collections, and to adjust the same, and make payment of the balances agreeably to law, and in case of refusal or neglect, to enforce the punctual performance of their duty; and the said intendant may, from special and peculiar circumstances, by his order in writing to either of the treasurers, or the clerk of the general court, direct that any collector's bond be not sued, or, if sued, that the action be continued or struck off.

To superintend collection, &c.

IV. AND BE IT ENACTED, That the said intendant be authorized to supervise the commissioners of the tax of the several counties, and to direct them in the execution of their office, and, in case
