II. BE IT ENACTED, by the General Affembly of Maryland, That the exclusive right, benefit and privilege, of making, constructing and felling, within this state, the said machines for carding and ipinning cotton and wool, shall be and is hereby vested in the said Robert Lemmon, his heirs, executors, administrators and affigns, for and during the space of fourteen years from the end of this present session of assembly.

III. AND BE IT ENACTED, That if any person or persons, during the faid term of fourteen years Penalty on o. aforefaid, shall make, construct or fell, within this state, any such machine for carding cotton or there making, wool, or for spinning them, or either of them, without a licence in writing first had and obtained from the faid Robert Lemmon, his executors, administrators or assigns, or shall purchase such machine or machines as aforesaid, within the term aforesaid, made by any other person than the said Robert Lemmon, his executors, administrators or assigns, or by some person licensed by him or them for that purpole, such person so making, constructing or vending, such machine or machines, or buying the same, or either of them, shall forfeit and pay to the said Robert Lemmon, his executors, administrators or affigns; the sum of fifty pounds current money, to be recovered in any court of record in an action of debt founded upon this act; provided always, that if on any action brought for the recovery of the faid penalty, it shall be proved that the faid Robert Lemmon was not the original inventor of the machine, for the making, felling or purchasing of which such action shall be brought, that the jury shall find their verdict for the defendant, and such defendant shall recover his costs.

C H A P. XXIV An ACT to determine by election whether the court-house and pri- Passed 20th of Jan. 1787. son of Harford county shall be erected at Belle-Air or at Havrede-Grace. Lib. TBH. No. B. fol. 115.

HEREAS fundry inhabitants of Harford have petitioned this general affembly for a law to Preamble, remove the feat of justice in said county from Belle-Air to Havre-de-Grace, and fundry other inhabitants of faid county have remonstrated against the said petition, and prayed that the seat of justice therein should continue at the place already established by law: And whereas it appears to this general allembly to be right and proper that the faid dispute should be finally determined by an election of the people, to which the faid parties have consented;

II. BE IT ENACTED, by the General Assembly of Maryland, That John Archer, Benedict E. Hall, Commissioners William Smith, (Bay-side,) John Taylor and Jesse Jarrett, and any two or more of them, be and appointed, &c. they are hereby appointed commissioners for the purpose of holding an election in the said county, to ascertain whether the court-house and prison of said county shall be crected at Belle-Air of Havrede-Grace, and they, or any two of them, shall hold the said election at Belle-Air on the first Monday in April next, and all persons qualified by the constitution and form of government to vote for delegates for said county shall have a right of suffrage in the said election; and the said commissioners, and any two or more of them, shall be the judges of the election, and may adjourn from day to day, if necessary, till the same be finished, so that it be concluded in fix days; and the said commitfioners shall summon two justices of the peace, who are hereby required to attend for the preservation of the peace; and the faid commissioners shall appoint a clerk or clerks to take the votes agreeably to the directions of this act, who shall, before he or they proceed to act, take the following oath or affirmation, as the case may be, to wit: " I, A. B. do swear, or solemnly, fincerely and truly de-" clare and affirm, that I will well and faithfully, without favour, affection or partiality, execute " the office of clerk of the elections under the act to determine by election whether the court-house " and prison of Harford county shall be erected at Belle-Air or at Havre-de-Grace, according to the " best of my judgment and knowledge; so help me Gon;" and the said commissioners, before they proceed to receive any votes, shall take an oath, that they will permit all persons to vote at the election to be held in virtue of this act, who in their judgment are qualified to vote for delegates for faid county; and that they will not permit any person to vote who is not qualified as aforesaid, if such person, before his voting, shall be objected against by any three of the voters; and that they will in all things execute the office of judges of the faid election, according to the belt of their knowledge, without favour, affection or partiality.
